

# INVITATION TO TENDER

## Rehabilitation Works on the St. Ann's (East Dry) River from Beetham Highway Upstream to the Vicinity of Belmont Circular Road

The NATIONAL INFRASTRUCTURE DEVELOPMENT COMPANY LIMITED (NIDCO) on behalf of the Ministry of Works and Transport wishes to invite suitably qualified and experienced contractors to submit tenders for the Rehabilitation works on the St. Ann's (East Dry) River from Beetham Highway Upstream to the Vicinity of Belmont Circular Road.

### DESCRIPTION OF WORK

The scope of the Project includes but is not limited to:

1. Clear & remove unwanted material/objects from site. All waste material must be disposed of responsibly, in an environmentally friendly manner, and at an approved dump site |
2. Excavation to design levels |
3. Backfilling works |
4. Place and compact hardcore material |
5. Place and compact Granular fill |
6. Cofferdamming works |
7. Concrete blinding |
8. Construction of Reinforced concrete Invert Paving |
9. Clean, clear and restore site.

### ELIGIBILITY

Submission of tenders is open to all contractors registered in Trinidad and Tobago who can demonstrate that they have the expertise, experience, and financial resources in projects of similar size and type as outlined in the Invitation to Tender. Evaluation of tenders will be based on requirements including: Organisation and Experience, Financial Capacity, Available Manpower and Resources and Method Statement.
